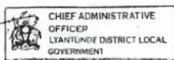


- iii) By any statement made or omitted to be made in the Draft Valuation List with respect of any ratable property, or
- iv) In case of building or portion of a building in parts by the valuation in the Draft Valuation List that building or portion of the building is a single ratable property may within **thirty (30) days** of publication of this notice serve notice of objection upon Lyantonde District Local Government to the Draft Valuation List in relation to the ratable property.

**NOTE:** A person shall not be entitled to be heard by the valuation court unless he/she had lodged a notice of objection within the stipulated time.
